Statement Pursuant to Section 19(a) of the Investment Company Act of 1940

On March 31, 2024, the Fund paid the following per share distributions on its classes of common stock to shareholders of record during the month of March 2024.

For the purposes of satisfying Section 19(a) reporting obligations, the Fund estimates that 100% of the distribution for this current month is attributable to a return of capital when calculated using GAAP. These amounts, calculated in accordance with GAAP, are not intended as a disclosure of the treatment of distributions for federal tax purposes.
